# V. Development, Licenses & Permits

2127 N 1st St (Albert Grand Residence): Developer presented plans at the June neighborhood meeting- board recapped the presentation. Board discussed if there is any conflict of interest being a board member and engaged in business activities with an active development project. It was proposed and agreed upon that the involved board member(s) would abstain from voting on anything that would have a direct impact on the outcome of the project.

- 232/234 E Brown St & 113 W Lloyd St: New excavation work scheduled for the Brown St project. The Property Owner spoke at the June neighborhood meeting.
- Literacy Services of WI (1737 N Palmer St): Open house announced for July 16.
- Other Projects: Updates provided for Sanger House Gardens (permit in progress) and other open permits in the neighborhood.

#### VI. Old Business

- Short-Term Rentals: Tracking ongoing; internal board logged addresses to be updated and resources to be added to our new website for residents.
- Property Assessments: Residents may need to follow up with the city on objections, reviews are ongoing.
