# V. Development, Licenses & Permits

- Updates include:
  - i. Apartment Building Development at 2127 N 1st St
    - 1. The board received a copy of the plans and is invited to a meeting with Jesse Wilkerson (Developer), Rev. Albert Grant (Owner), and Alderwoman Coggs on April 3rd to discuss the building planning process.
    - 2. Board doesn't have any immediate concerns regarding their plans, the designs look nice and historic.
  - ii. Two-block development site in the SE corner of BH (Hempel, ICAP Development)
    - 1. Approval for excavation work at 1929 N Buffum St from 03/11-06/11/2025 (appears to be for environmental testing)
  - iii. LSW at 1737 N Palmer St
    - 1. They continue to receive various permits/approvals
  - i. Pattee Group at 140 W Garfield Ave (former church)
    - 1. The board previously requested an update (last spoke at Feb 2023 Neighborhood Meeting)
  - ii. Royal Capitol at various lots in BH
    - 1. The board has requested an update from Royal Capital (last updates shared with the neighborhood were from April 2017)
